

HTI Graduate Nominated Ambassador to The Holy See



On July 22, **Dr. Miguel Diaz** (1998-1999 Dissertation Year fellow and HTI mentor) appeared before the U.S. Senate Committee on Foreign Relations as part of the nomination process for his appointment as Ambassador to the Holy See. Dr. Díaz, who served as an adviser to Barack Obama's presidential campaign, cited the President's recent words during his June visit to Cairo that this country is "shaped by every culture, drawn from every end of the Earth, and dedicated to a simple concept: E pluribus unum: Out of many, one." Dr. Díaz offered his "Cuban-American background as proof of the fundamental American value

of this country," asserting that two cultures shaped his identity, leading to his firm belief that his experience through interacting with diverse communities throughout his life have made him more open to others.

Dr. Díaz is a Professor of Theology at St. John's University and the College of Saint Benedict in Minnesota. He is the co-editor of *From the Heart of Our People: Explorations in Catholic Systematic Theology,* and author of *On Being Human: U.S. Hispanic and Rahnerian Perspectives*, the winner of HTI's first Book Prize award.

2009 HTI Book Prize Winner Announced

Connecting three time periods and three sets of competing sacred images for imperialism and counter-imperialism, the HTI Book Prize selection committee named **Dr. David Sánchez** (2005-2006 Dissertation Year fellow) as this year's winning author for his book, *From Patmos to the Barrio: Subverting Imperial Myths.* The interdisciplinary account engagingly presents the Mexican image of the Virgin of Guadalupe as a resource for resisting the dominant figure of the Virgin of Guadalupe as instilled by the Spanish conquistadors. The same image is then employed to counter the conquering Divine Destiny myth of American expansionism, in a similar way to how she is to be found in rallies for immigrant rights in our time. Dr. Sánchez, Assistant Professor of New Testament Studies at Loyola Marymount University, offered a lecture on his prize-winning work during this year's HTI Book Prize lecture. His compelling presentation elicited enthusiastic appreciation for the unexpected vehicles for expressing resistance to oppression, opening the door for a Call for Papers. HTI seeks submissions for a future issue of *Perspectivas* that address the Virgin of Guadalupe's powerful presence. Please refer to the Call for Papers on Page 7.

Consortium Member Institution Making Great Strides in Recruitment of Latinos



Southern Methodist University/Perkins School of Theology, a member institution of the Hispanic Theological Initiative Consortium (HTIC), is expending great efforts in attracting the growing Latino graduate population.

Dr. Carlos Cardoza-Orlandi (HTI mentor) was recently appointed as Professor of World Christianity. He joins fellow faculty member, Dr. Harold Recinos (HTI Mentor), Associate Professor of Christianity and Cultures, and Dr. Magallanes-Tejeda Hugo (2001-2002 Dissertation Year fellow), Professor of Church and Society. All three are deeply involved in research and scholarly activity related to Hispanic/Latino themes and would welcome working with Latina/o doctoral students. In addition, Dr. David Maldonado (HTIC Steering Committee member) heads the center for Study of Latino Christianity and Religions, Rev. Jeannie Trevino Teddlie heads the Mexican American program and Dr. Isabel De Campo serves as the Associate Professor of Supervised Ministry helping students with their internships.

The learning experiences offered by these seasoned scholars are not the only opportunities available. Potential students are encouraged to apply for a fellowship, consisting of an annual stipend of **\$16,000.00** and a waiver for the full tuition Additionally, the fellowship is renewable for two years, assuming satisfactory progress toward degree. The fellowship recipient would also have the great fortune to work on aspects of the Latina/o religious experience, choosing between any of the following fields to do their research: Old Testament/Hebrew Bible, New Testament, the Christian Tradition, Systematic Theology, Religious Ethics, and Religion and Culture.

Additionally, a fellow whose interests and objectives are compatible with the aims of the Hispanic Theological Initiative would also be supported as an HTIC Scholar. HTIC Scholars are assigned mentors, given networking funds, and participate in the HTI Summer Workshop where they have the opportunity to meet and work with Latina/o doctoral students and scholars from across the nation. Given the current economic crisis, this is a wonderful opportunity. Applicants are encouraged to apply by downloading the application, at SMU's website at: http://www.smu.edu/ PerkinsFacultyAcademics/GPRS.aspx; applicants should clearly express interest for this fellowship in the "statement of purpose."

We congratulate SMU/Perkins School of Theology for their ongoing efforts in opening the doors to aspiring scholars, and we look forward to continuing our collaborative work.

It feels like a family and this event provides a casual space to learn skills from other scholars that are very helpful to my immediate, and future, needs." The event's success urged another young scholar to suggest that we should "share this model with other scholarship programs.



The event concluded on Monday, with the group of fellows tired but appreciative of the opportunities they were given, leaving Princeton in high spirits and looking forward to facing the new academic year's challenges armed with their newly acquired skills, knowing that the HTI support network will continue, perhaps in ways they may not even yet imagine.

On August 17, **Dr. Milagros Peña** (HTI Selection Committee member and mentor) will leave her current position as Director of the Center for Women's Studies



and Gender Research at the University of Florida, to assume her new position as Associate Dean for Social and Behavioral Sciences, College of Arts & Sciences at the same institution.



Another HTI graduate, **Rev. Dr. Raúl Gómez Ruiz** (1999-2000 Dissertation Year fellow), Vice President for Academic Affairs, Director of Intellectual Formation, and Professor of Systematic Studies at Sacred Heart School of Theology, was recently named the recipient of this year's *Virgilio Elizondo Award* during the annual gathering of the Academy of Catholic Hispanic Theologians of the United States (ACHTUS), held in Chicago. The award is conferred to an individual "for distinguished achievement in theology, in keeping with the mission of the Academy." Rev. Gómez Ruiz received the award from Dr. Gary Riebe-Estrella (HTI Advisory Committee member).

Rev. Dr. Gómez Ruiz was also elected to the *Real Academia de Bellas Artes y Ciencias Históricas de Toledo* (Royal Academy of Arts & Sciences of Toledo), in the Academic Correspondents category. His election is based on having realized works meeting the goals of the Royal Academy. Dr. Gómez-Ruiz will travel to the beautiful city of Toledo in October to receive this important recognition.

Enthusiastically responding to an invitation extended by the *Seminario Evangélico de Matanzas* in Cuba, **Dr. Néstor Medina** (2002-2003 Dissertation Year fellow) recently spent four months teaching at that institution. He reports that he underwent a "process of cultural adjustment, and came out enriched in more ways than one: the way people interact, their concept of time, the way they relate to professors, and their own sense of identity in relation to the U.S., among other things." The institution's rector expressed his profound appreciation for Dr. Medina's collaboration, and expects to invite him back next year.

National Catholic Hispanic Ministry Symposium held at Boston University

From June 8-10, an unprecedented effort initiated by scholars at Catholic universities, sixtythree carefully chosen participants from all over the country came together for the first ever "National Symposium on the Present and Future of Catholic Hispanic Ministry in the U.S." The event, held at Boston College, was co-sponsored by that institution along with Lovola Marymount University and Barry University. Responding to the urgent need to form leaders for service to the U.S. Catholic community (which will be majority Hispanic in less than 20 years) the gathering included theologians, pastoral leaders, liturgists, youth leaders, specialists in religious education and persons in church leadership at the national and international levels. Members of the Steering Committee for the gathering included Dr. Roberto Goizueta (HTI mentor), Professor of Catholic Theology at Boston College, and Dr. Cecilia González-Andrieu (2006-2007 Dissertation Year fellow), Assistant Professor of Theological Studies at Loyola Marymount University. Each of the study groups will propose concrete steps for implementation and identify areas in need of further conversation and exploration. The final documents will be published bilingually in early 2010 by Convivium Press and distributed by several renowned national presses. Copies will be made available to dioceses around the country. The hope is that local communities will then carry on their own processes of dialogue about the issues and find ways to clarify their goals and enhance their programs in Hispanic Ministry.
