The Graduate Theological Union and HTIC Reap the Fruits of Combined Resources

The Graduate Theological Union (GTU) is "Where Religion Meets the World," which is why the GTU finds the mission of the Hispanic Theological Initiative Consortium (HTIC) so compelling. "The GTU attracts students from across the country and around the world, but our location in a minority-majority state where well over 1/3 of our state's population is Latina/o reminds us regularly of the need to prepare women and men for the Academy who exemplify our learners," said **Dr. Maureen Maloney** (HTIC Steering Committee member), GTU Vice President for Student Affairs and Dean of

Students, and a member of the HTIC Steering Committee.

The GTU strives for "inclusive excellence," reflected in the demographical profile and experiences of its students, faculty, and staff. According to Dean Maloney, graduates are another measure of this excellence, and the opportunities that the HTIC provides contribute directly to student retention and completion. Faculty mentorship restores and/or supports students' sense of giftedness and vocation before the concerns and burdens of doctoral study can get the better of them. The summer workshop enhances HTIC students' abilities, skills and potential as teachers and provides networking opportunities with contacts outside their particular academic, denominational, and research circles, enabling them to get their voices heard in the Academy.

Since **Dr. Eduardo Fernández** (1997-1998 Post-Doctoral fellow), Associate Professor of Pastoral Theology and Ministry with the Jesuit School of Theology of Santa Clara University, became the GTU's first HTI scholar in 1997, HTI has selected thirteen GTU students for its programs. Eighty-five percent of GTU-HTI scholars have completed their graduate studies and HTI doctoral graduates complete their degrees, on average, in 5.7 years compared with the overall average GTU doctoral time to degree of 7.1 years.

GTU-HTI graduates secure teaching positions throughout the United States and pursue their vocation in a variety of ways. **Dr. Jorge Aquino** (2005-2005 Dissertation Year fellow), Assistant Professor in Theology and Religious Studies with the University of San Francisco is also Director of the USF Catholic Studies and Social Thought Interdisciplinary Minor. **Dr. Cecilia González-Andrieu** (2006-2007 Dissertation Year fellow), Assistant Professor of Theological Studies with Loyola Marymount University, collaborates on workshops for faith formation

and leadership training at the Archdiocese of Los Angeles, the Dioceses of San Jose and San Diego, and LMU's Center for Religion and Spirituality. **Dr. Joseph DeLeon** (2003-2004 Comprehensive Exams Year fellow) currently teaches courses in religion, literature, and philosophy at Central Pennsylvania College and directs the Lebanon County affiliate of Bridge of Hope National. **Dr. Michelle González Maldonado** (1999-2000 Comprehensive Exams Year fellow & HTI Book Prize winner), Assistant Professor in Religious Studies with the University of Miami, is about to publish her fourth book titled, *Shopping: Christian Explorations of Daily Living* (Fortress Press, forthcoming in November 2010).

"This kind of success is a testimony to the individuals themselves, no doubt," said Dean Maloney, "though we believe the GTU provides the kind of environment in which talented people can thrive." We also believe it would be hard to obtain and maintain these kinds of metrics without the work of the HTIC."

Dr. Michael E. Lee Declared Winner of the 2010 HTI Book Prize



The HTI Book Prize selection committee gave a unanimous thumbs-up to **Dr.**Michael E. Lee (2003-2004 Dissertation Year fellow), Assistant Professor of Theology at Fordham University. Dr. Lee's work, Bearing the Weight of Salvation: The Soteriology of Ignacio Ellacuría was deemed worthy of the prize with its depth of research and its clear potential for becoming the standard study for a generation invested in the works of liberation theology. Dr. Lee will give a lecture on his winning entry on July 17th during the HTI Summer Workshop.

Cheered on by his very proud family, **Eric Barreto** (2008-2009 Dissertation Year fellow) celebrated his recent graduation at Emory University. In his position as Assistant Professor of New Testament at Luther Seminary, he has "quickly proven himself to be a fine teacher and strong community leader," as stated by Dr. Roland Martinson, Academic Dean and Professor of Children, Youth and Family Ministry at Luther. Dr. Martinson expressed that "Eric is an effective online Greek instructor, and he has established substantive relationships with students who seek him out for conversation and counsel. As a member of the seminary's Diversity Committee he is becoming a strong advocate for students of rich backgrounds of faiths, races and cultures. We expect great things from Eric now and in the future."

Tommy Casarez (2004-2005 Doctoral Renewal Fellow) not only successfully defended his dissertation, but his work was also deemed worthy of the magna cum laude honorary citation enthusiastically conferred by a committee comprised of Dr. Peter Paris, Professor of Christian Social Ethics at Princeton Theological Seminary, Dr. Douglas Massey, Professor of Sociology and Public Affairs at Princeton University, and Dr. Mark Taylor (HTI mentor), Professor of Theology and Culture, also



at Princeton Theological Seminary. Dr. Taylor, who chaired the committee and was Tommy's advisor, shared that his former advisee "has been dogged and discerning in his construction of a sophisticated response to current debates about Mexican immigration. His clear and articulate knowledge of the problematic, still receiving too little attention from Christian theologians, was easy to see during his recent dissertation defense."



Transcontinental flights are tiring, but Jacqueline Hidalgo (2007-2008 Dissertation Year fellow) was more than happy to endure the long flight from Massachusetts, where she is Assistant Professor of Latina/o Studies and Religion at Williams College, to don cap and gown for her graduation at Claremont Graduate University. CGU doctoral student, Richard Newton, shared that, "Having just begun my own doctoral studies at CGU, I often wonder where this path will lead me. The attention and sense of purpose undergirding Jackie's work has left deep footprints in which I hope my work

may follow. Whether hearing Jackie's voice in a casual conversation, from the lectern of a professional conference, or in the words of her writings, it encourages me to make the most of the academic experience.

Carmelo Santos (2005-2006 Dissertation Year fellow) received the blessings of his congregation at St. Mark's/San Marcos Lutheran Church in Springfield, VA, where he is associate pastor, to attend his graduation at Lutheran School Theology (LSTC) in Chicago. Dr. Vítor Westhelle, Professor of Systematic Theology at LSTC, describes Carmelo's work on science and pneumatology as "daring, exploring uncharted territories, and bringing into conversation two not-so-friendly fields. In doing so, he is raising the bar for interdisciplinary studies, while placing a special focus of concern in addressing his very own Latino heritage."

The University of Notre Dame conferred the doctoral degree to **Ernesto Valiente** (2007-2008 Dissertation Year fellow), who is Assistant Professor of Theology at Boston College. His colleague, Dr. Nancy Pineda-Madrid, Assistant Professor of Theology, voiced her endorsement for BC's hiring of Dr. Valiente, who in her own words "brings great zeal, commitment and passion to his teaching and research." As Dr. Pineda-Madrid shared, "he is the best kind of theologian because he brings enough life experience to know what really matters and has the drive to see the

theological dimensions in the matters of life. Not only is he sharply insightful, and he is that, but he is also a man of great wisdom, one who is grounded in his love of God and love for the Christian tradition."

At Garrett-Evangelical Theological Seminary, **Manuel Villalobos** (2009-2010 Dissertation Year fellow) successfully defended his dissertation. Manuel's advisor and Professor of Old Testament, Dr. Osvaldo Vena, expressed his admiration for Manuel's work stating that, "he brings to the study of the gospel of Mark the fruits of a life-long engagement with the Holy Scriptures and his own personal biography of marginality and otherness. The end product is a real *tour de force* through the enigmatic characters that inhabit Mark's passion narrative, and it is a welcoming breath of air into the sometimes stagnant atmosphere of the academic world."

She will be the inaugural dean of the fifth school at Asbury Seminary, and has most recently been professor of Church History and Theology at the Seminary.



Dr. Andrews says, "Zaida's excellent scholarship, her extensive involvement in the Latina/o community, her high regard among colleagues, and her commitment to Asbury Seminary and its mission position her very favorably to provide strong academic leadership as Dean of the School of Urban Ministry on the Florida Dunnam campus."

Additionally, Dr. Maldonado Pérez has been selected as one among 15 deans from theological schools in the United States and Canada to participate in a colloquy sponsored by the Wabash Center for Teaching and Learning in Theology and Religion during 2010-11. The colloquy "is designed to provide a forum in which deans explore the overall mission of theological education, articulate new insights, reflect on their own leadership styles and best practices—in community with others engaged in the unique vocation of academic deanship in a theological school." Dr. Carmen Nanko-Fernández (HTI mentor & Selection Committee member) was awarded tenure and promoted to the rank of Associate Professor at the Catholic Theological Union in Chicago. She was also appointed Director of the Ecumenical Doctor of Ministry Program at the beginning of the 2009-10 academic year.



Dan Castillo (2009-2010 Doctoral fellow) submitted a paper in response to the annual Call for Papers of the Koinonia Journal, Princeton Theological Seminary's PhD Student Journal. Of the many submissions on the theme "The Future of Creation" from doctoral students around the country, his stood out to the Koinonia Editorial Board in a blind review process. Daniel, who is PhD candidate at the University of Notre Dame, presented his paper, "To Cultivate and Care for Creation: The Human Voation as the Unifying Principle for Ecological Theology and Soteriology," in Koinonia's Annual Form on February 19, 2010 along with four

others and responses by three doctoral students from Princeton Theological Seminary. The Published versions of these papers will appear in the journal's 2010 issue.

Teaching Under a Cool Shade: Dr. Gregory Cuéllar in Cuba

Responding to the need for an experienced voice, B.H. Carroll Theological Institute asked Dr. Gregory Cuéllar (2005-2006 Dissertation Year fellow) to return to Cuba for a second time to teach a week-long graduate level intensive course to a group of 70 students. The course, El libro de Isaias (40-55): El exilio y el retorno (The Book of Isaiah: the Exile and the Return), found Dr. Cuéllar sharing the shade of a palm leaf roof in the open air with his students, who were primarily pastors and seminary professors, representing various evangelical and protestant denominations (Pentecostal, Baptist, and Methodist). The students enthusiastically praised Dr. Cuéllar, stating that the theology of The Diaspora left them with the challenge of how they, as ministers, can apply it in different situations, not only those of migration, but wherever those in the margins without a voice to express their plight are found. The students also said that they look forward to seeing Dr. Cuéllar's work published in Spanish.

Catholic Theological Union recently named **Dr. Miguel Diaz** (1997-1999 Dissertation Year fellow & HTI Book Prize winner), Ambassador to the Holy See, as the recipient of the "Blessed Are the Peacemakers Award." The award is given to "an individual, a family, or an institution that exemplifies the commitment to peacemaking and reconciliation that is an important value of the school's mission." Some of the past award recipients include: Lea Rabin, John Hume, Rev. Theodore M. Hesburgh, Eunice

Kennedy Shriver, Sargent Shriver, Steven Spielberg, Jean Vanier, and Queen Noor. Additionally, Fordham University conferred an honorary degree to Dr. Díaz at its 165th commencement on May 22nd.



Dr. Felipe Hinojosa (2008-2009 Dissertation Year fellow), Assistant Professor of History at Texas A&M University, has been awarded a First Book Grant from the Louisville Institute for the 2010-2011 academic year. This award will allow Dr. Hinojosa to be released from teaching duties to work on completing his book project, "*Los Aleluyas*: Faith, Activism, and Identity among Latino/a Mennonites." His colleague, Dr. Carlos Blanton, Associate Professor of History, finds that "Felipe is at the top of his field and

one of the most gracious and kind colleagues one could hope to have. This national award is an important recognition of the significance of Felipe's work and indicative of the high regard with which top scholars in the field hold his expertise. It is also a nearly immediate validation of the wisdom of the Hispanic Theological Initiative for supporting his work. We at Texas A&M University are very proud of our new colleague and congratulate him on his demonstrated excellence at such an early stage of his career."

On June 12, 2010 the congregation of the Church of Saint Matthew and Saint Timothy in New York City will celebrate the appointment of **Rev. Carla Roland-Guzmán** (2003-2004 Comprehensive Exams Year fellow) as the 13th rector of that parish. Her milestone is also a milestone for her church, as she will become its first female rector and the first Latina rector of the Episcopalian diocese she serves.

Wabash-sponsored "Educating Nuestra Gente" at Palmer Theological Seminary

On March 27, 2010, Palmer Theological Seminary held a Wabash Center-sponsored event titled "Educating Nuestra Gente for Ministry: Theological Education and the Latino/a Evangélica Community," that gathered 25 well-known evangélica/o (Protestant) educators, grassroots leaders, and non-Latina/o Protestant educators to examine critical issues that impact the theological education of Latinas/os. Specifically, the conference asked the question: "Is there an identifiable evangélica/o way of teaching that resonates with the Latina/o Protestant community, and which subsequently creates a hospitable space for their learning in academic institutions?" Notable evangélica/o scholars participating on a panel during the event included:

- Dr. Robert Pazmiño (HTI workshop leader), Professor of Christian Education at Andover Newton Theological School.
- **Dr. Daisy L. Machado** (former HTI director, HTI mentor), Professor of Church History at Union Theological Seminary, NY.
- **Dr. Nelson Rivera,** Associate Professor, Systematic Theology and Hispanic Ministry at Lutheran Seminary.
- **Dr. Elizabeth Conde-Frazier** (1997-1998 Dissertation Year fellow, Selection Committee member, Advisory Committee member), Academic Dean at Esperanza College.
- **Dr. Loida I. Martell-Otero** (1999-2000 Dissertation Year fellow, HTI workshop leader), Associate Professor of Constructive Theology at Palmer Theological Seminary.

The annual **HTI Summer Workshop** will take place from July 16th to July 19th, 2010 on the campus of Princeton Theological Seminary. The HTI staff will welcome nineteen students who will attend a variety of workshops tailored to their particular levels of study, led by a group of experienced leaders who will have the doctoral candidates working on assignments prior to their arrival in Princeton. Nine of these students will learn the ins and outs of the HTI's hallmark mentoring program, working

with HTI graduates who benefited from the mentoring experience themselves. Other workshops will cover such topics as preparing for comp exams, writing a dissertation proposal, and enhancing study skills, among others. One of the highlights of the annual workshop will be the HTI Book Prize lecture, given by **Dr. Michael E. Lee** (2003-2004 Dissertation Year fellow), winner of this year's prize. The respondent to Dr. Lee will be **Dr. Gustavo Gutiérrez**, Professor of Theology University of Notre Dame. The lecture will take place on July 17th at 7:00 p.m. in Stuart 6 on the campus of Princeton Theological Seminary, followed by a reception in the Mackay Campus Center. This event is open to the general public.

Her readings of the biblical narratives from a perspective of *resolviendo* offer insights in the struggle for survival many Cubans face today. Also explored are the implications that a reading through the notion of *resolviendo* or survival can have for other contexts in contemporary societies where survival is at stake. The author is Hospice Chaplain at the United Hospice of Eastern Carolina – Smithfield.



Theologizing en Espanglish: Context, Community and Ministry, by Dr. Carmen Nanko-Fernández (HTI mentor & Selection Committee member), was recently published by Orbis Books. The book presents a collection of essays where the author discusses a wide variety of themes common in Latina/o theologies: mestizaje, preferential option for the poor, linguistic hibridity, popular religion, daily life ("lo cotidiano"), the perils of representation, and others. Dr. Nanko-Fernández is Associate Professor and Director of the Ecumenical Doctor of Ministry Program at the Catholic Theological Union in Chicago.



Wipf & Stock Publishers announced the publication of *Women and the Landscape of American Higher Education: Wesleyan Holiness and Pentecostal Founders.* The author, **Dr. Abraham Ruelas**, adjunct professor at Fuller Northern California, compiles the inspiring stories of some of the most notable women who, from society's perspective stepped outside established roles to claim a significant place in the history of American higher education.



Also by Wipf & Stock Publishers, *After Heresy: Colonial Practices and Post-Colonial Theologies* by **Dr. Vítor Westhelle**, makes an important contribution to post-colonial theological studies by presenting the argument that religious practices and teachings imposed on colonized peoples are transmuted in the process of colonization. Dr. Edwin Hernández (HTI Advisory Committee member), announces the completion of the report, Healing Hands: The Health of Latino/a Churchgoers and Health Outreach among Latino Congregations in Chicago.
